Rental Agreement

Below are the rules and regulations that must be followed in order to rent a court. If any of the rules are broken there will be a service charge or possibly no rentals in the future. Please circle Volleyball or Bocce for the court rental you want.

Bocce Ball Court Rental

- Cost per court (lane) \$50/hour
 - Any additional time must be paid with the front desk at the time of request (if available)
- Maximum number of people/court is 12
 - If more than 12 people are attending, an extra \$10/person will be added to your invoice
- All rentals come with 8 bocce balls (4 of each color) and 1 pallino
 - Pallino must be held with a credit card or ID
 - If Pallino is lost/not returned, you will be charged a replacement fee of \$25
 - If you want more Bocce balls a fee of \$5 will be added to your invoice

Volleyball Court Rental Agreement

Below are the rules and regulations that must be followed in order to rent the court. If any of the rules are broken there will be a service charge or possibly no rentals in the future.

- Cost per court \$100/hour
 - **VB TEAMS ONLY**: M-F 4pm-10pm \$150/hour (no extra person fee)
 - If you want to extend you must pay before at the front desk (if available)
- Maximum number of people/court is 12 (excluding VB teams)
 - If more than 12 people are attending, an extra \$10/person will be added to your invoice
- You must bring your own balls
 - If you want to rent a cart of balls (10 total), \$15 will be added to your invoice
- Net's will be adjusted by the staff. Nets are not allowed to be adjusted by any clients or patrons. Please check the box of net height you prefer:
 - Mens
 - Juniors
 - Womens
 - Coed

General Court/Building Rules

- NO FOOD OR DRINKS ALLOWED ON THE COURTS
 - If something spills on the court (not water) a cleaning fee of \$25 will be added to your invoice
- Once your rental is over/complete you will be asked to leave the court to allow staff to clean/prepare for next court rental

Deposit: All reservations made ahead of time (not walk-ins) will be subject to a 50% charge in order to reserve your reservation.

Cancellation Policy: 24 hours from scheduled rental time for full refund. Less than 24 hours, you will not receive your deposit back. No show, no notice, your account will be charged for the full rental amount.

Damage Policy: Client will be held liable for any damage done to City Beach property by the attendees due to their gross negligence or willful misconduct. Client will be responsible for the full replacement value.

Liability Waiver Policy: Client has knowledge that all activities produced by City Beach require a liability waiver to be signed by all participants. All participants of legal age have the opportunity to sign a waiver at our facility upon entering. All participants under legal age will need to either be accompanied by a guardian who can sign the waiver on their behalf, or bring a pre-signed waiver with them. If a liability waiver is not received when a participant arrives then they will not be allowed to take part in any activities produced by City Beach.
